**(II) TEACHING AND RESEARCH EXPERIENCE :** In accordance with the TEQ Regulation of NMC,2022 adopted for the Institutes of Super Specialty during transition period.

- 1) Associate Professor for three years in the concerned subject from a permitted/ recognized medical college/ institution.
- 2) Special training for three years in the respective Super Specialty subject in a teaching Institution / Centre of Excellence with dedicated service in that specialty.
- 3) Should have at least four Research publications ( at least two as Associate Professor)(only original papers, meta-analysis, systematic review and case series that are published in journals included in medline, Pubmed, Central Science Citation Index, Science Citation Index, Expanded Embase, Scopus, Directory of Open Access Journals (DoAJ) will be considered).
- 4) Should have completed the NMC recognized basic course in Medical Education Technology.
- 5) Should have completed the basic course in Biomedical Research from Institutions designated by NMC. And as amended by NMC from time to time.

**(III)** Permanent Resident Certificate of Tripura (PRTC) would be required while applying for jobs by direct recruitment as per Notification of GA (P&T) No.F.23(8)-GA(P&T)/2023 dated 07/07/23.

**DESIRABLE:** Knowledge in Bengali or Kok-borok.

**Age:-** Upper Age limit is 50 years as on **15.09.2025**. Relaxable by 5(five) years in case of SC/ST/PH/PWD candidates and Government servants candidates as per TME(Administrative & Faculty) Service Regulation Rules, 2015 However, the SC/ST/Govt. Servant will not get the further relaxation of 5(five) years over and above relaxation of 5(five) years which they are already entitled to get as SC/ST candidates.

**The last date of submission of online application is 15.09.2025 (upto 5.30 PM). The application (s) received after the closing date will not be entertained.**

**Other Important information:-**

**1. Online Application Portal:**

(a) Candidates will have to submit application through Online Application Portal only. The Commission will not entertain any hard copy application. Before submission of online application, read carefully the instruction to candidates.

(b) Link for Online Application Portal will be available on Commission's website from **21.08.2025 to 15.09.2025 (5.30 PM)**. Before applying for the post, an applicant (New user) shall register his/her bio-data particulars through One Time Profile Registration (OTPR) on the Commission's Website viz. <https://tpsc.tripura.gov.in> Once applicant registers his/her particulars, a User ID is generated and sent to his/her registered mobile number and email ID. Applicants need to apply for the post using the OTPR User ID through the Commission's website.

(c) Applicants should avoid submitting multiple applications. However, if due to any unavoidable circumstances, any applicant submits multiple applications then he/she must ensure that the application with latest Receipt Number is complete in all respect.

(d) In case of multiple applications, the application with latest Receipt Number shall only be entertained by the Commission and fee paid against one Receive Number shall not be adjusted against any other Receipt Number.

2. (a) Candidates are required to submit self attested copy of certificates in support of their claims regarding Age (date of birth certificate/ Admit card of Madhyamik), Educational Qualifications Madhyamik on words ( all marksheet and certificates), Attempt Certificate of MBBS, PG and Super Specialist , Medical Registration Certificate from the appropriate authority, Permanent Resident Certificate (PRTC), Scheduled Castes/Scheduled Tribes certificate, Experience Certificates, API score **(as per Annexure-A )** and as per supporting API Score sheet, if mentioned in the application in the receipt section of the TPSC . Submission of such documents will be allowed up to 07(seven) working days of closing date of receipt of Online application i.e. within **23.09.2025(5.30 PM)** along with printed copy of filled up Online Application Form failing which candidature will be treated as cancelled. The Commission will not entertain any application thereafter.

(b) Applicants must be in possession of the prescribed minimum qualification(s) and others for the post on the closing date **(i.e. 15. 09. 2025)** for submission of application as mentioned in the advertisement. Their admission at all the stages of recruitment process will be purely provisional, subject to their satisfying the prescribed eligibility conditions. Mere issue of admission certificate to the candidate will not imply that his/her candidature has been finally cleared by the Commission.

(c) On scrutiny of documents, if a candidate is found ineligible as per terms and condition of the advertisement (including prescribed recruitment fees), his/ her candidature will be rejected. If the application is not routed Through Proper Channel, at the day of interview candidates will have to submit 'No-Objection' certificate failing which his/ her candidature will not be considered for preparation of final merit list. In that No-Objection certificate, it is to be clearly mentioned that your employer has '**No-Objection**' if you are considered for recruitment to the post for which you have applied for.

3. (a) Group-A Posts:- Rs.400/- (Rupees Four Hundred) only for General Candidates and Rs. 350/- (Rupees three Hundred and Fifty) only for ST/SC/ BPL card holders/Physically Handicapped Candidates.

(b) Recruitment fee so deposited, is non-refundable.

(c) If a candidate submits incomplete application in respect of terms & condition of the Advertisement and without requisite recruitment fee, his/her candidature will be rejected.

(4) Decision of the Commission as to the eligibility or otherwise of a candidate at any stage of the selection process shall be final.

(5) Assessment and evaluation of necessary documents done by the Commission shall be final and shall not be open to scrutiny by any external authority.

(6) The Examination venue shall be closed 10 minutes before the Scheduled Commencement of Examination. No candidate shall be allowed entry into the examination venue after closure of entry. No functionary has any direction in this regard.

(7) Candidates are at liberty to making correction(s) in any field(s) of the 'Online Application Form' for the respective advertisement after closing day of submission of online application window of the said advertisement. The window for making correction(s) only will remain open for 7(seven) days from the closing day of submission of 'Online Application Form'.


After completion of such process the Commission will not entertain any application/representation for making correction(s) in any field(s) of the 'Online Application Form'.

(8) Candidates are instructed to visit the Commission's website for information regarding steps of recruitment process time to time.

(9) Mobile Phone/Electronic Gadgets etc. are banned in the Campus of the Examination Premises/Interview Premises. Any Phone/Electronic Gadget found in possession of any candidate in the Examination Premises/Interview premises shall be confiscated forthwith and he/she may be debarred from appearing at the Examination/Interview and also for the Examination(s)/Interview to be conducted by the Commission in future Violation of such instruction will be dealt as per Law.

**Method of direct recruitment for Regular Super Specialty faculty Post ( Professor) :**

Selection through TPSC through Academic Performance Index (API) and Interview -API 90 Marks + Interview -10 marks, Total 100 marks.

**API score for direct recruitment of Super Specialist Cadre**

- 1) MBBS Degree :Total Score -10 marks
  - i. 1<sup>st</sup> Professional Examination-2.5 marks ( Passed in First attempt)
  - ii. 2<sup>nd</sup> Professional Examination-2.5 marks ( Passed in First attempt)
  - iii. 3<sup>rd</sup> Professional Examination-2.5 marks ( Passed in First attempt)
  - iv. 4<sup>th</sup> Professional Examination-2.5 marks ( Passed in First attempt)
  - v. Full marks will be awarded who passed all professional exams in 1<sup>st</sup> attempt
  - vi. ½ (half) marks will deducted from each professional exam for each additional attempt ( more than one) to pass the professional examination (From total marks of 10).
  - vii. 5 or more additional attempt to pass the professional examination will invite zero (o) marking the obtained marks of a candidate from the concerned professional exam ( From total marks of 10)
- 2) PG (MD/MS/DNB) Degree (Broad Specialty): Total Score- 25 marks.
  - I. Full marks will be awarded who passed his/her Post Graduate examination (MD/MS/Diploma/DNB equated to DM/ M.Ch- (for disciplines under the super Specialties group as per Teachers Eligibility Qualification(TEQ)Medical Institutions Regulations, 2022 of NMC in the concerned subject and as amended by NMC from time to time) in 1<sup>st</sup> (first) attempt (Total marks 25).
  - II. 3(three) marks will be deducted for each additional attempt ( more than one) to pass the Post Graduate professional examination ( From total marks of 25).
- 3) Super Specialist (DM/M. Ch/ DNB) Degree : Total Score-25 marks.
  - I) Full marks will be awarded who passed his /her Post Graduate examination (MD/MS/Diploma/DNB equated to DM/MCh- (for disciplines under the super Specialties group as per Teachers Eligibility Qualifications (TEQ) Medical Institutions Regulations, 2022 of NMC in the concerned subject and as amended by NMC from time to time) in 1<sup>st</sup> (first) attempt (Total marks 25).
  - II) 5 (five) marks will be deducted for each additional attempt (more than one) to pass the Super Specialist Degree ( From total marks of 25 ).

4) Publications: Total Score-10 marks.

- i) Research publication /case report in international & national Journal Approved by NMC @ 4 marks and 3 marks respectively ( Total marks 20).
  - ii) Publication must comprise with the latest NMC/ MCI approved indexed Journal.
  - iii) No marks will be added for Non Index Journal or publication not comprising with latest NMC/ MCI guideline for publication of Journal.
  - iv) Research paper/Case Report must be published during Super Specialty Study period & post Super Specialty period.
  - v) Candidate must be first, second or Correspondence Author of the Publications, otherwise the marks of publications will not be added.
- 5) Post Doctoral Fellowship of concerned subject after Super Specialty -10 marks
- 6) Gold Medal in any stage of Medical Qualification- 5 marks
- 7) Service Experience- beyond the minimum eligibility criteria as per TEQ regulation of NMC, 2022- Total 5 marks @ 2.5 marks per year with maximum marks of 5 for experience in related Super Specialty Subject.
- 8) Interview: 10 marks

**Total Score = 10+25+25+10+10+5+5+10=100**
