Candidates with Benchmark disabilities will be governed as per the Ministry of Social Justice & Empowerment, Government of India "THE PERSONS WITH DISABILITIES (EQUAL OPPORTUNITIES, PROTECTION OF RIGHT AND FULL PARTICIPATION) ACT, 1995" of the Department of Ministry of Law, Justice and Company Affairs Gazette publication dated 1st January,1996 & subsequent amendments.

To apply for the aforementioned post, the applicant must have Permanent Resident Certificate of Tripura (PRTC). This is in pursuance of GA(P&T) Department

Notification dated 07-07-2023.

The Educational Qualification and Age are mentioned below:-

Educational Qualification:-

- a) He/ She shall have passed at least Higher Secondary (H.S+2) or equivalent examination from a recognized Board/University with minimum 35% marks in average or He/ She shall have passed Madhyamik examination with Stenography Course from any ITI with 35% marks in Madhyamik.
- b) He/She shall have knowledge of operating Computer and a certificate from any Govt. or Govt. recognized or Govt. registered Institution or University which may be of minimum duration of 3 (three) months.

He/ She shall have proficiency in typing in English on computer and shorthand writing/ transcription with minimum speed of 40 words per minute and 100 words per minute respectively.

- c) He/ She shall be of sound physical and mental health and free from any bodily defect which may render him unfit for such appointment;
- d) The qualifying marks as mentioned in (a) above is relaxable by 5% marks for all reserved category (SC/ST/Ex-serviceman/P.H) candidates.

Age:- Minimum 18 years & Maximum 40 years as on 23.09.2025 Upper age limit is relaxable by 5(five) years in case of SC/ST/PH candidates and Government Servant. The Government employees belong to ST/SC/PH category shall not get this relaxation over and above the General relaxation of 5 years available to them.

The last date of submission of online application is <u>23.09.2025</u> (upto 5.30 PM). The application(s) received after the closing date will not be entertained.

SYLLABUS AND OTHER CONDITIONS OF SELECTION PROCESS:-

- (a) As per Service rule the Recruitment process will comprise of three successive stages viz. i) Preliminary Examination of 100 marks (Multiple Choice Type Test OMR based) (Time allowed- $1\frac{1}{2}$ hours) ii) Type Writing (using Computer) of 100 marks and Shorthand Writing & Transcription (using Computer) of 200 marks and iii) Main Examination of 250 marks (Conventional Type Test) .
- **(b)** For detailed Syllabus of Preliminary Examination please refer GA(P&T) Department Notification vide No. F.35(11)-GA(P&T)/72(II) dated **14**th **March 2022**.
- (c) A limited no. of candidates, maximum 5 (five) times of total vacant posts (in category wise), will be selected merit wise for Type Writing test & Shorthand Writing & Transcription Test on the basis of the result of Preliminary Examination, subject to securing minimum qualifying marks as fixed by the Commission.

(d) It is also mentioned here that candidate(s) scoring marks equal to that of the last qualified candidate in the Preliminary Examination shall also be called for next

stage of the recruitment process.

The Preliminary Examination is a Screening Test only to select candidates for the Type Writing & Shorthand Writing & Transcription Test. The marks obtained in this Examination by the candidates will not be taken into account for the purpose of preparing the final merit list.

(e) Minimum 50% marks will be the qualifying marks in respect of Type Writing & Shorthand Writing & Transcription, relaxable up to 40% in case of SC/ST candidates.

(f) The candidates who will be found qualified in the Type Writing & Shorthand Writing & Transcription test will be called to appear in the Main Examination.

(h) The Candidates will have to choose Bengali or Alternative English during submission of online application. The Commission will not entertain any request thereafter.

(i) For detailed Syllabus of Main Examination please refer 'Annexure-I'

(j) The final selection will be made in order of merit on the basis of the marks obtained by a candidate in Main examination plus the marks obtained in the Type Writing & Shorthand Writing & Transcription Test. If a Candidate remains absent himself/herself in the Type Writing or Shorthand Writing or Transcription Test and any paper of the Main Examination, his/her candidature will not be considered for final selection.

(k) In the list of recommendation, merit position of candidates securing equal

marks will be finalized as per their seniority of age.

The same procedure is to be followed for preparing waiting List, if there be

any.

Further provided that, in the list of recommendation, merit position of candidates securing equal marks in aggregate and also of the same age will be decided on the basis of percentage of marks obtained in the minimum educational qualification prescribed in Recruitment Rules/ Service Rules.

- (I) Ranks of the candidates are not prepared for the candidates beyond the recommendation list & wait list (if there be any).
- (5) The Examination will be conducted as per the Secondary (Madhyamik) standard.

Other Important information:

1. Online Application Portal:

- (a) Candidates will have to submit application through Online Application Portal only. The Commission will not entertain any hard copy application. Before submission of online application, read carefully the instruction to candidates.
- (b) Link for Online Application Portal will be available on Commission's website from 29.08.2025 to 23.09.2025 (5.30 PM). Before applying for the post, an applicant (New user) shall register his/her bio-data particulars through One Time Profile Registration (OTPR) on the Commission's Website viz. https://tpsc.tripura.gov.in Once applicant registers his/her particulars, a User ID is generated and sent to his/her registered mobile number and email ID. Applicants need to apply for the post using the OTPR User ID through the Commission's website.
- (c) Applicants should avoid submitting multiple applications through different registration. However, if due to any unavoidable circumstances, any applicant submits multiple applications then he/she must ensure that the application with latest Application Number is complete in all respect.
- (d) In case of multiple applications, the application with latest Application Number shall only be entertained by the Commission and fee paid against one Application Number shall not be adjusted against any other Application Number.
- 2. (a) With their respective application candidates are not required to upload/submit any certificate/document in support of their claims.
- (b) Applicants must be in possession of the prescribed minimum qualification(s) and others for the post on the closing date (i.e. 23.09.2025) for submission of online application as mentioned in the advertisement. Their admission at all the stages of examination for which they are admitted for the Preliminary Examination, Type Writing Test & Shorthand Writing Test & Main Examination will be purely provisional, subject to their satisfying the prescribed eligibility conditions. Mere issue of admission certificate to the candidate will not imply that his/her candidature has been finally cleared by the Commission.

- (c) After publication of result of Preliminary Examination, successful candidates will be asked to submit self attested copies of the relevant documents i.e. Age proof certificate(birth certificate/Admit of Madhyamik), Educational Qualifications (Madhyamik onwards)Mark sheets & Certificates, Permanent Residence Certificate of Tripura (PRTC), Scheduled Tribes/Scheduled Casts/PH/Ex-SM certificate (if any), as per recruitment rule minimum 03 months duration's computer operating Certificate, etc. to the Reception Counter of TPSC or By post addressed to the Secretary, TPSC, Agartala, PIN-799001. Submission of such documents including through post will be allowed up to specified time along with forwarding letter failing which candidature will be treated as cancelled. The Commission will not entertain any documents thereafter.
- (d) On scrutiny of documents, if a candidate is found ineligible as per terms and condition of the advertisement (including prescribed recruitment fees), his/ her candidature will be rejected. If the application is not routed Through Proper Channel, at the time of documents submission candidates will have to submit 'No-Objection' certificate failing which his/ her candidature will not be considered for preparation of final merit list. In that No-Objection certificate, it is to be clearly mentioned that your employer has 'No-Objection' if you are considered for recruitment to the post for which you have applied for.

(3) Rate of Recruitment Fees:

- (a) Rs. 200/-(Rupees two hundred) for General Candidates and Rs.150/-(Rupees one hundred & fifty) only for ST/SC/ BPL card holders Candidates.
- (b) Recruitment fee so deposited, is non-refundable.
- (c) If a candidate submits incomplete application in respect of terms & condition of the Advertisement and without requisite recruitment fee, his/her candidature will be rejected.
- (4) Decision of the Commission as to the eligibility or otherwise of a candidate at any stage of the selection process shall be final.
- (5) Assessment and evaluation of necessary documents done by the Commission shall be final and shall not be open to scrutiny by any external authority.
- (6) The Examination venue shall be closed 10 minutes before the Scheduled Commencement of Examination. No candidate shall be allowed entry into the examination venue after closure of entry. No functionary has any direction in this regard.

(7) Candidates are at liberty to making correction(s) in any field(s) of the 'Online Application Form' for the respective advertisement after closing day of submission of online application window of the said advertisement. The window for making correction(s) only will remain open for 7(seven) days from the closing day of submission of 'Online Application Form'.

After completion of such process the Commission will not entertain any application/representation for making correction(s) in any field(s) of the 'Online Application Form'.

- (8) Candidates are instructed to visit the Commission's website for information regarding steps of recruitment process time to time.
- (9) Mobile Phone/Electronic Gadgets etc. are banned in the Campus of the Examination Premises/Interview Premises. Any Phone/Electronic Gadget found in possession of any candidate in the Examination Premises/Interview premises shall be confiscated forthwith and he/she may be debarred from appearing at the Examination/Interview and also for the Examination(s)/Interview to be conducted by the Commission in future Violation of such instruction will be dealt as per Law.
- (10) Any kind of enquiry regarding eligibility criteria, candidates are advised to approach the concerned Government Department. The Commission will not entertain any representation in this regard.
- (11)Entry in the Examination hall/Interview Premises with Jacket, Coat, Pull over & this type of garments will not be allowed.

NOTIFICATION

In exercise of the powers conferred by sub-rule (4) of Rule – 13 of the Tripura Government Stenographers' Service Rules, 1977, the State Government in consultation with the Tripura Public Service Commission, hereby makes the following regulations to amend the Tripura Stenographers' Service (Direct Recruitment through competitive examination) Regulations, 1979 namely:

I. Short title and commencement:-

These regulations may called the Tripura Stenographers' Service (Direct Recruitment through competitive examination) (9th Amendment, 2022) Regulations, 1979.

They shall come into force on and from the date of their publication in the Official Gazette.

(II) Amendment of Regulations-4.

In clause – (viii) of the Regulation – 4 of the Tripura Stenographers Service (Direct Recruitment through competitive examination) Regulations, 1979, syllabus for Preliminary Examination shall be substituted as under:

Syllabus of Main Examination for recruitment to Personal Assistant, Grade-II(PA-II)

Examination shall be conducted in the following subjects/papers as per the secondary (Madhyamik) Standard:-

The details of the Papers: topics to be included and pattern of questions are as under:-

(1) Paper - I (English)

- (a) An exercise in composition to test a candidate's ability to write in simple and correct English. It may be an essay or drafting a report or a letter of about 400 words from points or materials supplied.
- (b) To write a précis of a series of correspondence or a summary of given passage to test candidate's capacity of comprehension and expression.
- (c) Translation from Bengali, Kokborok, Hindi as the case may be, to English.
- (d) Correction of sentences.
- (e) Punctuation.
- (f) Correct use of words and common phrases.

(2) Paper - II (Bengali)

- (a) An essay or a letter of about 400 words to test a candidate's ability to write in elegant Bengali.
- (b) To condense a prose passage of about 1000 words.
- (c) Translation from English to Bengali.

OR

(2) Paper - II (Alternative English)

A. Questions will be set from the following pieces:

PROSE

- (1) The Selfish Giant (Oscar Wilde).
- (2) A daily Drama (Jerome K. Jerome).
- (3) Narayan Hemchandra (M.K. Gandhi)

POETRY

- (1) We are seven (William Wordsworth)
- (2) Breathes there the Man (Walter Scott).
- (3) To one who has been long in city pent (John Keats).
- (4) Where the Mind is without Fear (Rabindranath Tagore)
- (5) Time, You Old Gipsy Man (Relph Hodgson).
- (6) The song of the Palanquin Bearers (Sarojini Naidu).

B. The pattern of questions will be:

- (1) Objective Type (on Text)
 (Filling up of blanks, Antonyms, Synonyms).
- (2) Short (informative) questions.
 (Who is the speaker, to whom said, place of occurrence etc.)
- (3) Broad questions. (Within one paragraph, or description central idea).
- (4) Textual Grammar
- (a) Punctuation.
- (b) Transformation:-

Four sentences from the Text will be set for

- (i) Change of voice
- (ii) Change of Narration
- (iii) Change of kind of sentences
- (iv) Change of Degrees of comparison
- (c) Substitution of Idioms for words:-

(Five) sentences are to be from the Text. Three of them are to be attempted. One word in each sentence is to be italics. Right idioms are to be substituted for the italicized words.

(3) Paper - III (General Knowledge & Current Affairs)

The paper will consist of questions to test the extent of a candidate's knowledge and his/her capacity to express himself/herself correctly on matters of common knowledge and current events and problems with special reference to India. Elementary knowledge of Indian History and Indian Geography may also be tested.
