INTRODUCTION

1. Brief History

1.a Background

As provided by the Government of India Act 1919, the Lee Commission was constituted in 1923 under the Chairmanship of Lord Lee for the purpose of formulating principles /terms and conditions of Public Service and submitted its report in 1924 A.D. This led to the establishment of the first Public Service Commission on October, 1926 under the Chairmanship of Sir Ross Barker. The limited advisory function accorded to the Public Service Commission and the continued stress on this aspect by the leaders of our freedom movement resulted in the setting up of a Federal Public Service Commission and also Public Service Commission at the Provincial level under the Govt. of India Act, 1935. After Independence, the Constituent Assembly visualized the need for giving a secure and autonomous status to Public Service Commission, both at the Central and at the State level, for ensuring free and fair recruitment for the Public Service as well as for protecting the rights of Civil Servants, thus Public Service Commission was given a Constitutional status by promulgation of Constitution of India on 26 January, 1950.

Under Part XIV, Chapter I and in Articles 308 to 314 of the Constitution of India , the matter related to services under the Union and the States such as recruitment and conditions of service or person serving, tenure of office of persons serving, dismissal, removal or reduction in rank of persons employed have been provided.

Under Chapter II, subject to the provisions of the Article - 315, there shall be a Public Service Commission for the Union and a Public Service Commission for each state.

1.b Tripura Public Service Commission

Before attaining Statehood on 21st January, 1972, Tripura was under jurisdiction of the Union Public Service Commission. After attaining Statehood, 'Tripura Public Service Commission' was established on 30th October, 1972 as per the provisions of Article 315 of the Constitution of India. Sri G. P. Bagchi was the 1st Chairman and Sri I.K. Roy was the 1st Member of the Tripura Public Service Commission.

In exercise of the powers conferred by Article 318, the Tripura Public Service Commission Regulations were framed by the Governor of Tripura in 1972 and as per said Regulations, the Commission shall consist of a Chairman and one or more Members not exceeding 3 (three) as may be determined by the Governor from time to time. The Chairman and Members so appointed are assisted by a Secretariat headed by the Secretary.

Tripura Public Service Commission is also regulated by the Tripura Public Service Commission (Exemption from Consultation) Regulations, 1973 framed by the Governor of Tripura as per provision of clause (3) (e) of Article 320 of the Constitution of India in respect of its functional activities.

1.c Function of the State Public Service Commission

As per provisions of the Article 320 of the Constitution, the function of the State Public Service Commission shall be:-

1. Recruitment for Civil Services and Civil posts as per provisions of the Tripura Public Service Commission (Exemption from Consultation) Regulation, 1973 framed by the Governor of Tripura by:
 - i. By Direct Interview;
 - ii. Examination (Scheduled) followed by Personality Test / Viva- Voce;
 - iii. Screening Test (Non- Scheduled) followed by Interview;
 - iv. The Tripura Combined Competitive Examination for Recruitment to miscellaneous posts;
 - v. Conduct of Departmental Examination / Pre-Promotional Examination;
 - vi. Conduct of U.P.S.C. Examination at Agartala Centre.

2. The State Public Service Commission shall be consulted:
 - i. On all matters relating to methods of recruitment of Civil Service and for civil posts of the State Government;
 - ii. On the principles to be followed in making appointments to Civil Services and posts and in making promotions and transfers from one service to another and on the suitability of candidates for such appointments, promotions on transfers;
 - iii. On all disciplinary matters affecting a person serving under the Government of the State in a civil capacity, including memorials on petitions relating to such matters;
 - iv. On any claim by or in respect of a person who is serving or has served under the Government of the State in a civil capacity, that any costs incurred by him in defending legal proceedings instituted against him in respect of acts done or purporting to be done in the execution of his duty should be paid out of the consolidated fund of India, or as the case may be, out of the Consolidated Fund of the State;
 - v. On any claim for award of a pension in respect of injuries sustained by a person while serving under the Govt. of India or the Government of a State, in a civil capacity, and any question as to the amount of any such award.
3. And it shall be the duty of Public Service Commission to advice on any matter so referred to them and on any other matter which the President, or as the case may be, the Governor of the State, may refer to them.

Provided that the Governor, in respect of other services and posts in connection with the affairs of the State may make regulations specifying the matters in which either generally, or in any particular class of case or in any particular circumstances, it shall not be necessary for a Public Service Commission to be consulted.

1.d Expenses

Under Article 322, the expenses of the State Public Service Commission, including any salaries, allowances and pensions payable to or in respect of the members of the Commission, shall be charged on the Consolidated Fund of India or as the case may be, the Consolidated Fund of the State.

1.e Reports of the Public Service Commission

It shall be the duty of the Commission to present annually to the Hon'ble Governor of Tripura, a report as to the work done by the Commission and on receipt of such report, the Governor shall cause a copy thereof together with a Memorandum explaining, in respect of the cases, if any, where the advice of the Commission was not accepted, the reasons for such non-acceptance to be laid before each House of Parliament/State Legislative Assembly.




Figure : 1.1 - Organizational Chart of the Commission.

3. Secretariat of the Commission


The total sanctioned strength of officers and staff in the Commission as on 31st March, 2023 was 97 (including 02 Contractual Post). Of which, 15 were Gazetted while 82 were Non-Gazetted including Contractual and Group-D. Man in position is 63 (including 11 Supernumerary Post) and remaining 40 posts were vacant for the period 01-04-2022 to 31-03-2023. In addition to that, 01 no. of PS-III/PS-IV and 01 no. of PA-II are engaged in the Commission.

SUMMARY OF ACHIEVEMENT

1. Total Requisitions Processed by the Commission:-

The Commission received 16 requisitions for recruitment of 832 posts from various Government Departments during the year under report. Taking into account of 14 carried over requisitions for 778 posts, the Commission dealt with in total 30 requisitions for 1610 (832 +778) posts.

2. Summary of Total requisitions:-

- a) **Recommendation through Examination and Interview/Viva-voce:-**The Commission recommended 136 no. of candidates [UR= 55 nos, SC= 24 nos., ST= 57 nos.] candidates through Skill Test , Examination and Interview/Viva-voce.
- b) **Recommendation through API and Interview/Viva-voce :-** The Commission recommended 107 [UR= 64 nos, SC= 7 nos., ST= 36 nos.] candidates through Interview/Viva-voce.
- c) **Recommendation through Skill Test & Examination:-** The Commission recommended 50 no. of candidates [UR=23 nos, SC=11 nos., ST=16 nos.] candidates through Examination and Interview/Viva-voce.
- d) **Requisition Carry forwarded to next year:-** The Commission could not complete the 18 requisitions in the year under report and carry forwarded to the next year.

3. Departmental Examinations/Pre-Promotional Examinations:-

During the year under report, the Tripura Public Service Commission dealt with 08 Departmental Examinations. Out of 08 Examinations, 04 were completed during the year and remaining 04 carry forwarded to next year 2023-24.

4. Conduct of UPSC Examination at Agartala Centre:-

The Commission dealt with 05 UPSC Examinations during the year under report.

5. Total Applications Received and Processed by the Commission:-

During the period under report, in total 85,826 (UR-45961, SC-13253 and ST-26612) applications were received by the Commission for Direct Recruitment. Brief descriptions of the recruitment process are given in Chapter-4. 1092 (UR-476, SC-195 & ST-421) candidates appeared before the Interview Board/Examination along with Skill Test and finally 293 nos of candidates were recommended for appointment to various posts.

6. Promotion and Recommendations:-

During the year under Report, the Commission received 113 proposals from different departments, Government of Tripura for Promotion / Regularization. Finally, the Commission conveyed its concurrence in respect of all proposals in the year under report.

7. Departmental Promotion Committee Meeting:-

During the year under Report, the Commission dealt with 49 proposals through DPC meeting for selection of candidates for promotion / confirmation. DPC meeting were conducted for all 49 proposals in the year under report and for 44 proposals, the Commission recommended officers for promotion /confirmation.

8. Concurrence of Draft for Amendment of Recruitment Rules / Service Rules:-

The Commission dealt with 32 proposals regarding concurrence of Draft Recruitment Rules / Service Rules from the different departments, Government of Tripura and 32 proposals were concurred by the Commission during the year under report.

9. Disciplinary Proceedings cases:-

The Commission dealt with 17 proposals in connection with Disciplinary Proceedings cases from the different departments, Government of Tripura. The Commission has agreed with the proposals of the concerned departments against all cases.

10. Representation of Scheduled Tribes and Scheduled Castes:-

Recruitment process by Competitive Selection through the method of Interview/ Interview & Examination/ Skill Test with Examination was completed for the 119 posts reserved for Scheduled Tribes and 51 posts reserved for Scheduled Castes during the year under report.

11. Implementation of provisions of the Right to Information Act, 2005:-

Tripura Public Service Commission received 257 requests under the RTI Act. Taking into account of 09 carried over request, the Commission dealt with 266 requests in all. The Commission responded to 262 requests during the year under report. Remaining 04 request was disposed off after 31.03.2022 within time frame.

12. Legal Matter:-

During the year under report, in total 37 Writ petitions were filed in which Secretary, Tripura Public Service Commission was one of the respondents on various matters like direct recruitment, disciplinary proceedings etc. After hearing, the Hon'ble Supreme Court of India/Hon'ble High Court of Tripura disposed off/dissmissed 15 nos of Writ Petitions/Writ Appeal/SLP and remaining 22 Nos. Of Writ Petitions/Writ Appeal/SLP were in hearing stage.

Out of 37 Writ Petition, Secretary, Tripura Public Service Commission was 1st respondent in 5 (five) Writ Petition which are on direct recruitment by Tripura Public Service Commission. Out of the 5(five) cases, 3(three) cases were disposed off/dissmissed by Hon'ble High Court of Tripura.

13. Public Grievance:-

During the year under report, the Tripura Public Service Commission received 07 nos public grievances on different matters which were downloaded from PG Portal. All the public grievances were disposed off during the year under report at TPSC level only.




Figure: 3.1 Comparative Study of posts advertised by the Commission against ST, SC and UR candidates for last 06 years.




Figure: 3.2 Comparative studies of last 06 years applications received by the Commission against ST, SC and UR candidates.




Figure: 3.3 Comparative study of last 06 years ST, SC and UR candidates who appeared in the Interview/Viva Voce/ Examination with Skill Test.




Figure: 3.4 Comparative study of last 06 years ST, SC and UR candidates who are recommended.




Figure: 3.5 Total no. of RTI cases received disposed within time limit and disposed after 31st March of the year since last 06 years.

REPRESENTATION OF ST AND SC CANDIDATES

During the year under report, Commission dealt with 170 [51 (SC) and 119 (ST)] posts reserved for Scheduled Tribes and Scheduled Castes. 109 ST candidates and 42 SC candidates were recommended through Skill Test with Examination, Examination followed by Interview/Viva-voce and Interview only.

Right to Information Act, 2005 mandates timely response to citizen making requests for Government information. 


Figure: 7.1 - Records of Cases during the year 2022-23




Figure : 7.2 - Public Grievances during 2022-2023
