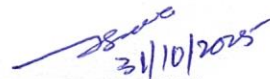

Terms and conditions:

- i) The quotation shall be submitted in the prescribed format given above (Table-B), along with an Earnest Money Deposit (EMD) of ₹.1,000/- (**Rupees One Thousand only**) for each vehicle. The EMD must accompany each quotation in the form of a Bank Demand Call (D. Call), failure to do so will result in summary rejection of the tender.

- ii) The successful bidder shall make full payment of the quoted price within 5 (five) days, failing which the offer will stand automatically cancelled and the deposited D. Call money will be forfeited.
- iii) Payment for the vehicle(s) auctioned value shall be made through cash or cheque only.
- iv) In case of failure to deposit the full value of the auctioned price, the earnest money deposited by the bidder will be forfeited.
- v) The Commission will hand over the condemned vehicle(s) only after receiving full payment of the auctioned price.
- vi) The undersigned reserves the right to reject any or all quotations without assigning any reason whatsoever.
- vii) The Commission will not bear any transportation cost. The selected buyer shall transport the condemned vehicle(s) at his/her own cost within 15 (Fifteen) days after depositing the full payment.
- viii) Firms/Person interested in the purchase of the vehicles may inspect the vehicles on any working day from 03.11.2025 to 15.11.2025 between 11.30 am to 3.30 pm at TPSC Office, Agartala.
- ix) The D.Call money of all the bidders shall be returned within one month of the auction date, without any interest.
- x) The buyer of the vehicle/vehicles shall be liable to pay any taxes or levies that may have to be paid to the relevant authorities, over the auctioned value. The Commission will not entertain any claim what so ever in respect.
- xi) The auctioned vehicle/vehicles, once sold, shall not be taken back to TPSC, on any condition whatsoever.
- xii) The quotations will be opened at 12:30 PM on 18th November 2025 in the presence of the quoter(s), if any.
