## NOTIFICATION

It is hereby notified that Departmental Examination for in-service Auditors under Grade-VI as per provision of the "Tripura Audit and Accounts Service Rules,2007 and Tripura Audit and Accounts Service(First Amendment) Rules,2018" will be conducted by the Tripura Public Service Commission on 30<sup>th</sup> November. 2022. All Officers desirous of appearing at this Examination are requested to submit application through Online Application Portal along with Application Fees of Rs.350/- on or before 5<sup>th</sup> September, 2022. Online Application Portal will be available on Commission's Website from 12.08.2022 to 05.09.2022 (5.30 PM). After the closing date of submission of online application, the Commission will refer entire list of candidates to Directorate of Audit (Finance Department), Government of Tripura for vetting of the Department towards permission to sit in the said Departmental Examination. The Commission will allow to sit the candidates in the examination only after receiving permission from the /Directorate of Audit (Finance Department.

Application received after the closing date will not be entertained in any case. The list of eligible candidates, Programme of the Examination & Admission Certificate(s) of eligible candidates will be uploaded in the Commission's website (<a href="http://www.tpsc.tripura.gov.in">http://www.tpsc.tripura.gov.in</a>) due time.

## **Online Application**:

- (a) Applicants will have to submit application through Online Application Portal only. The Commission will not entertain any hard copy application. Before submission of online application, read carefully the instruction to candidates.
- (b) Online Application Portal will be available on Commission's website from 12.08.2022 to 05.09.2022 (5.30 PM). Before applying for the post, an applicant shall register his/her bio-data particulars through One Time Profile Registration (OTPR) on the Commission's Website viz http://www.tpsc.tripura.gov.in. Once applicant registers his/her particulars, a User ID is generated and sent to his/her registered mobile number and email ID. Applicants need to apply using the OTPR User ID through the Commission's website.
- (c) Applicants should avoid submitting multiple applications. However, if due to any unavoidable circumstances, any applicant submits multiple applications then he/she must ensure that the application with latest Receipt Number is complete in all respects.
- (d) In case of multiple applications, the application with latest Receipt Number shall only be entertained by the Commission and fee paid against one Receive Number shall not be adjusted against any other Receipt Number.
- (e) Examination fee so deposited, is non refundable. Un-paid application is summarily rejected.
